POWERLESS**

GUARDIANSHIP REALITY:

- YOU ARE **LEGALLY DEAD** UNDER LAW!
- SOCIAL WORKERS **SIGNING UP** PEOPLE IN HOSPITALS
- OFTEN **A STRANGER** TAKES OVER & MAKES YOUR DECISIONS
- PEOPLE WITH CAPACITY HAVE BEEN DEEMED **INCAPACITATED**
- THOSE LACK DECISION MAKING CAPACITY, **DEEMED TO HAVE CAPACITY**
- PEOPLE HAVE BEEN **INSTITUTIONALISED** AGAINST THEIR WILL
- PEOPLE HAVE BEEN **ABDUCTED**
- VALID **EPOA** HAVE BEEN REVOKED
- **WILLS** HAVE BEEN CHALLENGED
- PEOPLE HAVE BEEN **ISOLATED** FROM LOVED ONES
- PEOPLE HAVE BEEN **OVER MEDICATED**
- ESTATES HAVE BEEN **LIQUIDATED**
- **COLLUSION** BETWEEN GROUPS & ORGANISATIONS

AUSTRALIANS ARE BEING **TARGETED** BY STATE & FEDERAL GOVERNMENTS
(AND THEIR ORGANISATIONS) WHO ARE **COMPETING** WITH VICTIMS
AND THEIR LOVED ONES/FAMILIES AS THEY BECOME VULNERABLE.

THEY ARE TARGETING THE MONEY & PHYSICAL PERSON

THESE ORGANISATIONS HAVE

ABSOLUTE POWER TO ENGAGE IN THESE BEHAVIOURS

UNACCOUNTABLE TO ANY AUTHORITY & UNMONITORED

LAWS THAT ALLOW THEM TO **IGNORE CRIMES AND EVIDENCE**

AND **ACT** AS THEY WISH. HOLD **HEARINGS IN SECRECY** AND **GAG**
VICTIMS/SUPPORT ONCE AN ORDER IS MADE.

APPEALS AND RECOURSE EFFECTIVELY IMPOSSIBLE

POWERS OF ATTORNEY

- A PERSON **LACKING CAPACITY** CAN BE SIGNED TO NEW EPOA
- YOUR VALID EPOA CAN BE **OVERTURNED** BY A TRIBUNAL, EVEN AFTER CAPACITY LOSS
- YOU CAN BE SIGNED TO NEW EPOA WHILST IN **HOSPITAL** AND VULNERABLE SETTING
- VULNERABLE AUSTRALIANS IN **RESPITE** AND OTHER SUCH SETTINGS ARE OFTEN SIGNED TO NEW EPOA WITHOUT FAMILY / CARERS PRESENT

LIFE SENTENCES HEARD BY TRIBUNALS ORIGINALLY CREATED TO HEAR SMALL CLAIM MATTERS

Evidence & stories will confirm that there is

- ILLUSION OF JUSTICE
- NO OVERSIGHT
- NO DUE PROCESS / RULE OF LAW
- NO ACCOUNTABILITY
- NO TRANSPARENCY
- UNLIMITED LEGAL RESOURCES
- UNLIMITED FUNDING
- TRUSTEES USE YOUR MONEY & DENY YOU ACCESS TO YOUR MONEY AGAINST THEM
- GOVT V'S INDIVIDUAL



THE MEDIA STORIES & INDIVIDUAL EXPERIENCES

- CAN **END UP IN CARE** STRAIGHT FROM HOSPITAL
- **ONE CONFLICT , FAMILY OR EVEN STRANGER-** ALL FAMILY REMOVED
- **SLIGHT DISAGREEMENT** WITH A SERVICE PROVIDER CAN LEAD TO REVOCATION OF EPOA (#VAN INQUIRY 2015 #SACAT AGED CARE ROYAL COMMISSION)
- PROVIDERS & TRUSTEES HAVE **SIDED WITH ABUSERS** AND NOT INVESTIGATED SERIOUS ALLEGATIONS
- PEOPLE WITH **DIMINISHED CAPACITY** BEING SIGNED UP LEGAL DOCUMENTS
- **WILLS BEING CHALLENGED** BY TRUSTEES –EVEN IF THERE IS NO OBJECTION
- END UP GUARDIANSHIP **EVEN IF YOU OBJECT** & HAVE CAPACITY
- **EVIDENCE IGNORED,** ALLEGATIONS NOT TESTED
- DEEMED **GUILTY-** FIGHT BACK TO PROVE INNOCENCE
- MEDIA SILENCED & FAMILY **GAGGED**

Guardianship is a backdoor way of stopping benefits:

- ✓ Stop Carers Pensions

- ✓ Reduction in medical costs for bulk billing & Health Care Card
- ✓ Stamp duty tax on estate sales (big push to liquidate real estate)
- ✓ Elimination public housing
- ✓ Dividends from trustees annually
- ✓ Probate fees etc. Disputes on wills feeds state more
- ✓ Reduction in hospital costs & beds & employment of staff in these areas by saving hospital beds
- ✓ Reduction in state support
- ✓ Reduction in home care from Local Government!
