



AUSTRALIAN CONSTITUTIONAL TRUST



ON THIS DAY THE FIRST DAY OF JANUARY IN THE YEAR OF OUR LORD TWO THOUSAND AND ELEVEN THIS DEED OF TRUST WAS ENTERED ESTABLISHING THE TRUST KNOWN AS THE AUSTRALIAN CONSTITUTIONAL TRUST SUCH TRUST BEING ESTABLISHED ABOARD THE DAWN PRINCESS WHILST IN INTERNATIONAL WATERS IN THE PACIFIC OCEAN AND WHEREAS THE SETTLOR SIR JOHN WALSH OF BRANNAGH, THE DUKE DE RONCERAY SETTLED THE FOLLOWING MONEYS ON THE TRUST NAMELY TEN ENGLISH POUNDS FIVE EURO FIVE AUSTRALIAN DOLLARS AND FIVE NEW ZEALAND DOLLARS AND WHEREAS UNITED PACIFIC CORPORATION PTY LTD WAS APPOINTED TRUSTEE AND WHICH TRUSTEE ACKNOWLEDGES HAVING RECEIVED THE SETTLED SUM AS MONEYS WHICH THE TRUSTEE AGREES TO HOLD UPON THE TRUSTS AND SUBJECT TO THE TERMS OF THIS DEED AND TO SO RECEIVE AND HOLD FURTHER MONEYS PAID INTO THE TRUST WHETHER BY WAY OF FEES OR GIFTS OR DONATIONS IN FURTHERANCE OF THE OBJECTS OF THE TRUST SUCH TO BE HELD IN A SEPARATE BANK ACCOUNT SUBJECT TO AUDIT TO BE USED IN FURTHERANCE OF THE OBJECTS OF THE TRUST NAMELY TO UPHOLD AND PROMOTE THE RULE OF LAW AND TO UPHOLD AND PROTECT AND PRESERVE THE CONSTITUTION OF THE COMMONWEALTH OF AUSTRALIA AND TO PROTECT THE RIGHTS OF ALL SUBJECTS OF HER MAJESTY QUEEN ELIZABETH 11 WHEREVER THEY MAY BE AND TO PROVIDE ADEQUATE AND PROPER LEGAL REPRESENTATION AND COUNSEL FOR AND IN THE PUBLIC INTEREST AND BENEFIT ON A PRO BONO OR REDUCED FEE BASIS TO THE PEOPLE OF AUSTRALIA AND ITS CONSTITUENT STATES AND TERRITORIES ALL SUCH BEING SUBJECTS OF HER MAJESTY QUEEN ELIZABETH 11 AND ALL SUCH BEING ENTITLED TO THE PROTECTION OF THE CROWN AND IN PARTICULAR TO ENSURE THROUGH THE COURTS AND THE JUSTICE SYSTEM THAT ALL SUCH PEOPLES OF HER MAJESTY'S REALMS AND DOMINIONS RECEIVE AND OBTAIN THE RIGHTS AND PROTECTIONS OF THEIR COMMON LAW HERITAGE AND THE FUNDAMENTAL LAWS AND STATUTES THEREIN INCLUDING BUT NOT LIMITED TO MAGNA CARTA THE PETITION OF RIGHT THE BILL OF RIGHTS THE ACT OF SETTLEMENT THE AUSTRALIAN COURTS ACT AND THE CONSTITUTION OF THE COMMONWEALTH OF AUSTRALIA SUCH OBJECTS AS STATED ABOVE BEING CONSIDERED CHARITABLE AT LAW AND IN THIS PUBLIC CHARITABLE PURPOSE PROVIDING GRANTS AND PAYMENTS FOR PURPOSES OF PROVIDING FUNDING FOR LEGAL COSTS AND DISBURSEMENTS FOR THOSE DISPOSSESSED AND DISADVANTAGED BY LOSS OF THEIR CONSTITUTIONAL RIGHTS BY ALL LEVELS OF GOVERNMENT WHETHER FEDERAL STATE OR MUNICIPAL AND BY

OTHER PERSONS AND ENTITIES THREATENING THE PROPER APPLICATION OF THE RULE OF LAW WHICH IS TO PROVIDE EQUAL PROTECTION AND JUSTICE TO ALL PERSONS AND IT IS NOTED THAT ALL MONEYS RECEIVED WHETHER BE WAY OF FEES OR DONATIONS IS TO BE USED SOLELY FOR PAYMENT OF COSTS AND DISBURSEMENTS WITH NO PART TO BE PAID TO THE SETTLOR OR THE TRUSTEE OTHER THAN AS REIMBURSEMENT OR PAYMENT OF EXPENSES INCURRED OR AS COMPENSATION FOR SERVICES RENDERED SUCH TO BE FAIR AND REASONABLE SUCH INCLUDING AN HONORARIUM TO UNITED PACIFIC CORPORATION PTY LTD LIMITED TO A MAXIMUM OF TEN PER CENT FOR PROVIDING SECRETARIAL AND ADMINISTRATIVE SERVICES TO THE TRUST AND FOR ACTING AS BARRISTERS CLERK IN RELATION TO THE PROVISION OF LEGAL SERVICES TO THE TRUST AND IT IS HEREBY NOTED THAT THE TRUST ASSUMES AND ACCEPTS AND INCORPORATES INTO THE TRUST THE LEGAL PRACTICE AND CLIENT BASE AND ASSETS AND LIABILITIES AND LAW LIBRARY OF THE LEGAL PRACTICE KNOWN AS DOCTORS' COMMONS WHICH LEGAL PRACTICE AS WAS ESTABLISHED ON NORFOLK ISLAND ON THE FIRST DAY OF JULY 2005 AND IT IS NOTED THAT AS FROM THE FIRST DAY OF JANUARY 2011 AND THEREAFTER THE TRUST ADOPTS AS THE FINANCIAL YEAR THE FIRST DAY OF JANUARY TO THE THIRTY FIRST DAY OF DECEMBER IN EACH YEAR ALL SUCH ACCOUNTS OF THE TRUST AND THE TRUSTEE BEING SUBJECT TO AUDIT WITH THE LAW GOVERNING THE TRUST TO BE THAT BEING LAWFULLY APPLICABLE ON NORFOLK ISLAND NOTING THAT THE OVERRIDING OBJECT OF THE AUSTRALIAN CONSTITUTIONAL TRUST BEING THE FULL LEGAL PROTECTION OF ALL CROWN SUBJECTS IN THE COMMONWEALTH OF AUSTRALIA.
